General Membership Meeting – September 2, 2009

Meeting called to order at 6:49. Governor Terry Burke filled in for President John Bechtel.

Welcome to members. Terry advised the meeting was starting early due to time needed for nominations for 2010 Board. Gloria Reiffer was congratulated on winning 1st Place in the NCCC Website Contest held at Convention in Colorado Springs. Terry advised that John and Sandy Bechtel were at the Corvette Caravan to Bowling Green; Chris Burke would be acting Secretary.

Reports:

Secretary: Sandy Bechtel, absent. Chris Burke stated that the meeting minutes from the August Board and Membership meetings were in the newsletter. There were no corrections or additions. Harold Leeman made a motion to approve the minutes, Simon Reiffer seconded. Minutes were approved.

Points Director: Ted Lasher reported that all points were updated on the website. Ted explained that if members participate in a non-CCCC event, they need to contact him so points can be credited.

Membership Director: Angela Hyde, absent. Terry Burke reported that membership totals are status quo, with 110, 1 honorary and 70 FCOA.

Social Director: Sue Politza, absent. Julie Lasher filled in and informed members that there will be a Drive & Dine hosted by Ed Root on 9.12.09, Horsepower at the Zoo on 9.20.09, Randy and Carol Putmon will be hosting their annual Barbecue and Hayride on 9.26.09, and Ted and Julie Lasher will be hosting the Fall Color Tour/Drive & Dine on 10.10.09. All information on these events and others are on the Website and in the newsletter. 13 member birthdays were recognized and candy bars handed out. Pat Cripe noted that Dave is turning 60. Julie stated that we may want to send a card to club sponsor Dick Iding.

Treasurer: Carol Putmon, absent. Terry Burke advised that all bills are paid under the current approved budget; members may see Carol for account balances.

President: John Bechtel, absent. Terry Burke urged members to help with Horsepower at the Zoo. Any help is greatly appreciated as this show is a large undertaking for the Club and is for a good cause. Simon Reiffer noted that we are considering collecting money up front at the gate for those not registered due to attendees not paying in the past. Volunteers are needed for this job; please contact Simon if you are interested. Simon also explained \$100 sponsorships and \$50 mini-sponsorships are appreciated from club members or business owners. Simon explained how the money has been distributed in the past by the zoo. Carlo and Janet Litrenta pledged \$100, as did Bob and Shalimar Maynard.

Webmaster: Gloria Reiffer, no report.

Competition Director: Ed Politza, absent. No report.

Public Relations Director: Simon Reiffer stated that a good time was had by all at the 2009 NCCC Convention in Colorado Springs. There were lots of activities and racing events, as well as giveaways. Simon estimated there were over 800 attendees. The 2010 Convention will be held in Palm Beach, FL. Simon explained the Corvette Nursery and the Corvette Museum. Report on Corvette Crossroads, all attendees had a good time despite the bad weather the day of the show. Simon advised that the owners of the hotel the club stays at are considering

offering a banquet dinner for club members in 2010. This would be in addition to room charges. Simon reported that the club Garage Sale has been moved to spring 2010.

Governor: Terry Burke reported that minutes from the Regional Governors meeting will be on the web or in the October newsletter; he has not yet received them from the Regional Secretary.

Old Business: None.

New Business: Bob Maynard asked that we keep Pam Platte and Kathy Cooper in our thoughts and prayers as they battle cancer. Bob also advised that Dar Day hit a deer with his Corvette. Discussion on parking fees for HAZ.

Terry Burke opened nominations for the 2010 Board of Directors. Terry suggested that members nominate anyone they feel would be suited to an open position. Gloria advised that being nominated does not obligate members to accept, but to hold objections until they are contacted by the nominating committee. Terry Burke advised that John & Sandy Bechtel would not seek re-election as President and Secretary for 2010. Nominations closed at 7:40.

Sunday, 9.13.09 is the Gilmore Car Museum car show and Beekman Center car show. Rich Bratschi advised that he received an email that needs to go the Governor or Competition Director, he will forward to Terry Burke who will direct it to the appropriate person. Rich Bratschi volunteered to sell 50/50 raffle tickets. During the sale of tickets, Terry Burke expressed the need to think about nominations or running for a position on the board. Simon Reiffer mentioned other club members that attended convention, and that fall will be bringing lots of fun rallyes which are a good way to earn points for the club. Pat Cripe mentioned that her brother runs an elderly care organization that is raffling off a Mustang, see her for tickets.

Carlo and Janet Litrenta won \$29 from the 50/50 raffle, and donated the proceeds back to the club.

Simon Reiffer made a motion to adjourn, motion seconded by Larry Warren, meeting adjourned at 7:55 pm.

Board Meeting – September 16, 2009

President John Bechtel called the meeting to order at 6:27 p.m.

Reports:

Secretary/Ambassador: Sandy Bechtel presented the minutes of the August 19, 2009 board meeting. Terry Burke moved to approve them as written. Ted Lasher seconded. Motion passed. Sandy reported that the Labor Day caravan to the museum was a hit. Approximately 7,500 Corvette enthusiasts participated in the five-day event. She noted the museum is altering the original plans for its motorplex. The facility will be larger, and will accommodate two road courses. The museum hired a firm from Chicago to evaluate sponsorship, naming rights, etc. Their report is due by the end of September.

Points: Ted Lasher reported points are on the website. The board discussed Ted's possible changes/clarifications to our points' language. Further discussion at the October board meeting.

Membership/Historian: Angela Hyde advised we currently have 110 regular, 1 honorary, and 70 Future Corvette Owners of America members. She also reminded us that dues of the 2010 membership year are due.

Social: Sue Politza reported the following upcoming club events: September 20, Horsepower at the Zoo; September 26, Putmon's BBQ/Hayride; October 10, Lasher's Drive & Dine/Color Tour; November 7, Bingo at Tamarack senior citizens apartments in Holt; December 2, Holiday Christmas Party at Coral Gables, East Lansing; and January 9, Winterfest at City Limits Bowling Center, Mason. Both the Holiday party and Winterfest cost \$25.00 per person and must be pre-paid.

Treasurer: Carol Putmon reported all bills have been paid under the current budget. She provided a list of all account balances.

Editor/Webmaster: Gloria Reiffer stated she is working on our website, including posting convention pictures. She also noted that because of the cost of toner cartridges and paper, it may be cheaper to have ASAP print our fliers for next year's Horsepower at the Zoo.

Competition: No report.

Public Relations: No report.

Governor/Vice President: Terry Burke gave a report of the recent regional NCCC meeting: All sanctioned speed events are done for 2009; 2009 membership should close out by September 30; NCCC has now updated all of their competition forms; the region stated unsportsmanlike conduct will not be tolerated at an NCCC or Corvette Club event; payment of a club's regional operating assessment should be by separate check, and not included with membership dues; a Trails Committee will be elected at the next regional meeting; the 2010 annual regional banquet will be held at the Clark Lake Golf Course on March 20, 2010 (\$21.00 per person, cash bar, appetizers); a club is needed to host the 2011 banquet.

President: John Bechtel noted we need to begin work on a proposed budget for 2010. Carol Putmon, John Bechtel, Sandy Bechtel, and Terry Burke volunteered to be on the committee.

Old Business: Sandy Bechtel stated plans are pretty much complete for next Sunday's Horsepower at the Zoo car show. Ted Lasher volunteered to take pictures of individual cars as another show money maker; John Bechtel stated Melissa from the Capital Area Muscle Car Club will count ballots.

New Business: Sandy Bechtel stated she, Colleen Bratschi, and Chris Burke are the nominating committee for the November board elections. They are currently contacting all people nominated at the September general membership meeting. It will be necessary to designate someone to receive the absentee ballots and bring them to the November general membership meeting unopened. Regarding Drive & Dine – Angela Hyde suggested that the hosts of a Drive & Dine put information on their flier regarding: the direction of the drive, estimated mileage, and cost range of the restaurant. Ed Politza stated he will provide information and/or a link for our website on how to access DIC (Driver Information Center) codes.

Member Comment: None.

Adjournment: Simon Reiffer moved to adjourn. Sue Politza seconded. Motion passed. Meeting adjourned at 8:09 p.m.

FINAL NOMINATIONS FOR THE 2010 BOARD OF DIRECTORS WILL TAKE PLACE AT THE OCTOBER GENERAL MEMBERSHIP MEETING.

We ask that you do not turn down nominations at the meeting. Take time to think it over. A member of the committee will contact those nominated to ascertain their willingness to accept the nomination. Please be assured that your name will not go on the ballot if you inform the committee member that contacts you that you don't wish to run for a board position. If nominated for more than one position you can let the committee know which position(s) you would be interested in serving. Members may also contact a committee member directly with questions, or to place their name in the running for an office.

In preparation for the election, all members are encouraged to review the CCCC By-Laws for a description of the duties of club officers. All board members must have their NCCC affiliation with CCCC (member number begins with MI-003).

The election of 2010 board members will take place at the November membership meeting. Absentee ballots will be available upon request. You must renew your CCCC membership for 2010 prior to the votes being counted.




