Ackermann Effect

Explaining the "Ackermann Effect" in the 2014 Corvette Stingray

If you take the all-new Stingray for a drive, you may notice something before you even leave the parking lot. This little something may seem like a defect, but it's not.


It's called the "Ackermann Effect", and although the issue was resolved 200 years ago, Chevy left it alone on the Corvette.

The reason? It's the same reason the Corvette has a 50/50 weight distribution and electric power steering: performance.

Explaining the Ackermann Effect:

Without getting into too much geometry and mathematics, the Ackermann Effect is a skipping or lurching of the wheels when the vehicle is turning sharply. The effect is created by the inside and outside wheels traveling at different speeds and distances.

Essentially the outside wheels are traveling further, creating a skipping or jumping effect.



A system, which was patented by Rudolph Ackermann in the 1818, turned the wheels at different angles and created a smooth turn for four-wheeled wagons.

Most cars use a system to mitigate the Ackermann Effect, the Corvette Stingray, however, goes without.

PROPOSED BYLAW CHANGES

The following are the proposed By Law changes for the CCCC as approved by the Board of Directors on May 17, 2017 to be approved by the membership at the June meeting.

If the CCCC Bylaws are in conflict with the NCCC Bylaws, then the NCCC Bylaws will take precedent.

Article I Section B-5: Change the spelling of good will to "goodwill".

Article II Section B: remove the dollar amounts and change the section with "All dues for the following calendar year will be determined by the Board of Directors at their September meeting and will be published in the October newsletter. If not published, the dues shall remain the same as the current year. Dues for a Spouse/Companion Member who is a NCCC member of another club shall be determined by the Board. If published, the change in dues will be voted on by the general membership at the October meeting.

Article V Section A-1:

Add; The President is authorized to sign checks or designate another Officer of the Board to do so in the absence of the Treasurer.

Article V Section A-5. Eliminate the names Secretary and President. Replace it with the "The

Treasurer shall update the signature card each time there is a change in either the Treasurer, President or other officer whose name appears on the signature card and files it with the financial institution which maintains the CCCC checking account.

Eliminate in a format auditable by the IRS.

The Treasurer shall file all Federal, State, and City Tax Returns every year as required by law along with any other forms that are required by law.

The books are subject to review if requested by the Board of Directors for an Audit Committee composed of at least three members, one of which is a past treasurer and all should have accounting or bookkeeping experience.

Section B-4: Change "they" to "The Webmaster shall"

Article XII Section A, Standing Rules: The minimum number of club members participating in a club social event for the event to be a "pointed" event within the Club's social point program shall be 10. The Points Director can determine on a case-by-case basis if leadership points may be awarded when fewer than 10 members participate in the event. In order for an event to be an official club activity, the event must be published in an email flyer or in the newsletter 10 days prior to the event.


