#### National Council of Corvette Clubs - RCD Meeting - May 10, 1996

This was Dale's first meeting as RCD as he was on a cruise during the February Meeting. He provided patches and rebates to all the regions for the 1995 Competition Season. Michigan received \$329.00 in rebates (Susan you will be happy to know that I still have the check and I know exactly where it is at.)

**Drag Records** -New drag record:

Group IA - 12.78/Sig Sutherlin

We discussed the possibility of increasing the number of national awards and the committee liked our recommendation of 15 places. This will become effective with the 1996 competition season and will affect the awards presented in 1997.

Waivers - how should we handle competition points if an entrant does not sign the waiver? Rulebook is very clear, no signature, entrant does not receive any points. A suggestion was made to conduct a roll call from the Waiver sheet at the Driver's Meeting and if not on the list you cannot compete. The decision was made that if someone does not sign, that person theoretically does not exist, therefore everyone else should move up.

Hoosier has new tires. Dale received a call from Hoosier asking where their tire would fit. Discussion pointed out "0" DOT (no street wear) rating and weight difference. Dean Lacky saw the tires in competition and they are considerably faster. The Rulebook specifically states Hoosiers are not included in Group I as they are defined as competition tires. (page 2-20)

Vote: 10 - 3 in favor of group 11. The new Hoosier tires will be placed in group II.

Clarification - Can '91 and up front and/or rear bumper covers be installed on an 1984 thru 1990 Vette and still run in Group I or I-S (NO) Unanimous

Clarification - Replacement intake manifold for a 70 LT1 -

there is no superseded part. Center bolts not the same, gaskets do not match, modification is necessary. (NO) Unanimous

NCCC Competition concerns -Dennis Patrick addressed the group regarding the possible future use of the Internet for schedules, point standings, Rulebook - increasing the way of communication for the future.

National Council is looking at some participation on the Internet. Rulebook is on a floppy and could be put on the Internet. We currently offer the rulebook to the NCCC membership only and books are sold. Donnie wouldn't have a problem with schedule on the Internet, but Rulebook and points could be a problem. sanction requests, flyers, points, etc. electronically. Security could be a real problem. We agreed that this is something that should be investigated, but carefully. We need to investigate safeguards.

Nancy Bailey was asked why she mailed minutes first class? She asked for each committee's view regarding 1st class vs bulk postage rate. One copy to each national officer, regional officer, and governor. Competition Committee recommended minutes should be mailed via 1st class mail.

Dean Lacky asked about any technical data in response to Holdridge's previous letter. . Two pages from Technically Speaking were provided to the group and Dean asked if anyone knew if there were any mistakes. It was decided that no one could really look over the two sheets and know right up front if there were any discrepancies. Clarifications need to be asked if

there are questions.

Insurance - what is the coverage from K & K - coverage is for the club. Liability coverage for guests at an event. Damage to facility for example. K & K does not provide road insurance for club trailers for liability. If a trailer is being towed to an event, it is not part of event, but the club would be covered for liability issues. Using trailer at the event. Some coverage if in restricted area. Equipment in restricted area is covered under liability issue.

Last few weeks Council has had an incident at a non-sanction event. Two cars hit, no damage, no claim was filed. No waivers were signed. Waivers should be signed regardless of event type. This would be good practice as it provides a good record of who was in attendance. This could be very important. The question was asked as to how many times people have to sign the waiver if more than one day event. Once per weekend is sufficient for common sites.

Round table Discussion -

Muffler for group I '84 and later. What does this include? Only muffler or muffler and pipes. System has to be factory available or OEM replacement. Muffler any commercially available in original position. Muffler climinator does not satisfy the requirement for muffler. We need more information regarding Mid-America's mufflers. Super-trap is not sold as a muffler, sold as a tuneable exhaust system. Is this a muffler or not? How do we tell if the piece is a muffler or not? The entrant needs to prove the piece is a muffler. Must be advertised and sold as muffler.

Jim Adrian (West Coast Region) has resigned as of the 15th of the month. They have no Competition Director at this time.

Novice Competition Class. Two person car, can one person run in Novice Class and one in regular class? "Yes" Novice can only obtain 30 points though and this sometimes becomes a problem that needs to be watched carefully.

Autocross - you are supposed to run the lowest class that you qualify for. What if no one is in my class, can I move up to next class? NO! Use the Rulebook strictly as written to determine class.

Sanction vs non-sanction - club can not contact insurance company for insurance without sanction or non-sanction number. It was suggested that all correspondence should go through the RCD. Dale will contact Dennis Patrick regarding a procedure that could be put in place for insurance inquires for all events.

What if scatter shield is not available for a group Group III car? If scatter shield is not available, an approved blanket can be used. (See Rulebook pg 2-25)

Novice Class points could possibly run over by a few points. This should be watched very closely by RCDs and make sure Novice entrants are moved into proper classes when necessary.

Declared city list. Could these cities be published? Dale suggests we contact him or the RCD of the region for correct declared city.

Navigator for Funkhana must be 16 years old including Convention event.

What is the definition of a race tire? No DOT rating, racing purposes only.

Funkhana for Convention.
Should points for this event be included for the overall competition award? Points have been included in the past.
Florida does not want to count any non-car event for points. It was the feeling from the RCDs that this should be left to the Florida Region.

Question on Sanction Request Form - do non-sanction request forms need to be sent to National? - "No"

Dale would like any information available on hand-controls installed in Corvettes.

If your flyer states the day the event will be conducted, you must hold on the day stated, you cannot carry over to the next day.

This is an important notice as events cannot be carried over to the next day. If the event is not run on the day it is scheduled for, it is considered canceled by Council's rules. This comes up frequently due to weather. It is an inconvenience but it is the only way to insure that everyone is being treated fairly.
