

COVERNORS REPORT

Dennis O'Hara, Capital City Corvette Club Governor

Well, we survived another fun filled, weather enhanced trip to Louisville to attend the November 15, 1997 NCCC Governor's meeting. Next meeting will be at the Executive West Hotel, Louisville, KY February 20 & 21, 1998.

Unfortunately the meeting started on a sad note - with a moment of silence. The passing of Larry Shinoda was noted. He played a large role in the past development of Corvette styling, including the 1963 split window. He will be missed.

The meeting report highlights follow:

NANCY BAILEY, NCCC SECRETARY: Minutes from the September meeting were accepted.

<u>JERRY LIMPACH, NCCC PARLIAMENTARIAN:</u> Read By-Law changes and discussed News Letter contest for 1998. Rules will be published in the next issue of Blue Bars. The issue of club in good standing was discussed and proxy Governor status. A club must be represented at the Board of Governors meeting to remain a club in good standing.

BETTY PARKS, NCCC TREASURER: Best report we have had in some time. The Charity Committee has re-paid the \$20,000 advance for the raffle car project; we have had the I.R.S. settlement taken care of; and the Bank Card rebate money has been credited and is current.

We have been approved as a 501(C)3 organization. What that means is, ...the raffle tickets for our annual corvette give-away is now tax deductible for what you spend.

The audit of NCCC is not complete at this time and there is not anything to report. The I.R.S. has been contacting local clubs as to their individual status - State and Federal tax exempt status are different.

DALE SAMUELSON, NCCC V.P. COMPETITION: The changes for the year 2000 Rule Book are beginning. Dale reported several new drag records throughout the county. The ones of most importance to us are the ones in Michigan. It was a SPINRAD SWEEP with Steve, Loretta and Tammy setting new records in their classes. WAY TO GO!!!

GAIL DAWLEY, NCCC V.P. MEMBERSHIP: NCCC currently has 13,108 members nationally. The results of our membership renewal is 53 members - all of which are NCCC members.

LARRY NARWOLD, NCCC DIRECTOR OF PUBLIC RELATION: NCCC will have an ad in Corvette Quarterly to attract new members. Corvette Fever has pictures of folks that were married at the Corvette Museum in the NCCC Diner Display; which, by the way, will continue to be on display until March of 98 - YOU GOTTA SEE IT! In March of 1998 the Pace Car will replace it.

For those of you that have a race car that you would like to show off, the Museum is looking for good examples to display. Drag cars, road course or whatever you have; if it looks good, they would like to see a photo for consideration - it doesn't even have to run. If you have something to show, let me know. I'll get you in touch with the right folks.

Web site advertising will be the focus for 1998 as we look for ways to reach new members.

<u>DENNIS PATRICK, NCCC BUSINESS MANAGER:</u> All the plant tour bills have been paid for the September event.

He gave us a rundown on the K&K claim history for the last 4 years: 1994 - 5 claims; 1995 - 3 claims; 1996 - 5 claims; 1997 - 3 claims. Overall, a good claims history. There are two open claims to-date. The coverage for next year will be the same premimun and coverage of \$1,000,000 liability, \$5,000 errors or omissions and property damage within 100 feet of the race track - in the pits, etc. The new coverage starts December 15, 1997.

The hotel arrangements for 1998 Governors Meetings are as follows: February/April, Executive West, Louisville; July, St. Louis at Convention; September/November, University Plaza, Bowling Green. The number of rooms have been expanded to 65 for 1998.

<u>JOHN OSBORNE, NCCC DIRECTOR OF PUBLICATIONS:</u> Deadline for the next publication of Blue Bars is December 1, 1997. Scholarship applications are available - deadline is May 1, 1998.

The new Director of Publications for Blue Bars was announced. Beginning in February, 1998, Loretta Spinrad will be responsible for the NCCC Newsletter - and producing the Blue Bars publication. WAY TO GO LORETTA!!

<u>JEAN MORRISON FOR PAT DOLAN, NCCC DIRECTOR OF CHARITY:</u> This was an abbreviated report due to the fact that Pat Dolan could not make the meeting. Jean reported that raffle tickets for the 1998 raffle car are available. The 100% clubs will be recognized again in '98 (that means we have to sell 50 tickets; one for

every NCCC member of our club). Jean also reported a \$20,000 donation by Corvette Troy to the Kidney Foundation.


SPOTLIGHT OS OUR MEMBERS


