

Since the general membership meeting Loretta has contacted the Traverse City Chamber of Commerce. The Convention needs a facility or a couple of nearly located facilities that could supply 350 rooms, a conference center and secure parking. So far the best facility to accommodate these needs is Shanty Creek. The Holiday Inn and Waterfront Inn submitted information, but do not seem to have adequate banquet space. Shanty Creek can also supply kids activities, has horse backing riding, canoe rental, golf and can help organize day trips to various attractions. Loretta will share her further findings with the general membership at the July 1st or 4th events.


