

Capital City Corvette Club Calendar of Events for October 1999 Congratulations on a job well done! I would like to thank Phil Zeller and Angie Zea, Phil and Cindy Hanses, and Mike and Nancy Dodson for their hard work in making our Convention Shirt Sales a success at the last Governor's Meeting. These folks did a fine job and their efforts are greatly appreciated.

We have done a lot over the last month all of which should prove to be beneficial with our convention planning.

First, there was the Labor Day Caravan to Bowling Green. This turned out to be a huge event with over 6,000 Corvettes and 60,000 people in attendance. The Michigan Caravan started at Oakland Community College in Farmington Hills with 300 cars and a lot of very anxious people. This gave us an opportunity to distribute the Convention Brochure and talk to people about next year at Shanty Creek. I am happy to report we received a very positive response.

As we left Michigan, the sight of 300 Corvettes was quite breathtaking to say the least. And a special thanks to the State troopers that helped us all the way to the Ohio border, I wish they could have continued on with us.

In Ohio we stopped at Bowling Green University for a short break and were joined by more Corvette Owners.

On the road again. Upon leaving Bowling Green it started to become a little bumpy, not with the pavement, but with the truck drivers. They were not happy with us and some were doing their best to make our drive a little uncomfortable. Lunch was a welcome relief.

When we stopped for lunch just south of Dayton, we were joined by a few more caravans coming from the east. Now our group was really growing which didn't help our situation with the truck drivers. Between the traffic congestion, construction, and the truck drivers, we struggled to stay together, but we finally arrived in Louisville about 5:00 p.m. Thursday evening where everyone had a chance to unwind and prepare for the next leg to begin on Friday.

It was exciting to see so many Corvettes in one place, but I don't think anyone was prepared for the sight they faced Friday morning, I know I wasn't.

Line up was once again early, very early, 6:30 a.m. It was still dark. As we pulled into the fairgrounds, you began to get a feel for the situation, but it was not until

the sun appeared over the horizon, did you know. Little by little 3,000 Corvettes had found their way to the staging area. The sight was unbelievable. The news media was overhead with helicopters, there were cameras and television personalities all over the place. It was a great experience!

Unfortunately, the lineup was one of the biggest highlights of the day as shortly after departing (15 seconds) the caravan was broken up due to an overturned truck on the highway. What a mess! It was as the caravan all of a sudden didn't exist, it was every person for themselves. Our group stayed together pretty well and made the best of the situation. We were fortunate as we all had CBs so we were able to stay in constant communication, which really helped.

We arrived in Bowling Green later Friday morning in plenty of time to explore the museum, exhibits, and vendor tents before collapsing at our hotel.

Our group worked hard promoting the Convention and my sincere thanks goes out to Bridget and Bill Stehouwer, Irene and Steve Quick, Nancy and Mike Dodson, Cindy and Phil Hanses, and my copilot, Steve. Everyone did a great job!

Between the Mackinaw Show, Bowling Green, and Governor's meeting the word is really starting to spread. If the response is any indication of what our convention participation will be, we may need to use all the space at the resort, including Schuss and the new hotel, Cedar River!

Convention planning has not been our only activity this month, even though it may seem like it at times, we did have our annual golf outing, Sunday the 19th. The turn out was a little disappointing, but we had a great time anyway. I can see Steve will need a new set of clubs soon. #### **Election of Officers**

We will be holding our annual election of officers at our December Holiday Dinner. Nominations will therefore be open at the October and November Meetings. If you have a desire to devote your time and efforts in supporting the club you may want to consider running for office. All positions are voted on each year.

**President** - must have served on the board at least one year prior to election. The president is responsible for the overall direction of the club and must be willing and able to oversee all events and positions if necessary. **Governor** - this person is the club's representative to the National. This person is expected to attend the NCCC Governor's Meetings and report back to the club on all NCCC activities.

Membership Director - this person is responsible for new member recruitment, handling renewals, and keeping track of all membership activities. It is expected this person will attend all CCCC functions to promote the club's activities.

Social Director - this person is responsible for arranging and promoting all CCCC social activities. It is also expected that this person will attend all CCCC social



functions to promote the club's activities.

**Public Relations Director** - this person promotes the clubs interest at events and solicates sponsorship monies and items. It is expected this person will attend all CCCC events to promote interest in the club.

**Points Director** - this person is responsible for keeping track of all the points for the general membership and providing a monthly update of points standings for the newsletter.

**Secretary** - this person is responsible for taking and publishing the minutes for all meetings. Minutes to be posted each month in the club newsletter.

**Treasurer** - this person is responsible for the club's treasury. Making deposits, balancing the books, making appropriate reimbursements to club members, and paying bills.

**Newsletter Editor** - this person is responsible for publishing the newsletter each month. This includes gathering reports, printing, and mailing the newsletter to all club members.

The position descriptions as outlined are defined in our bylaws; however, the board is currently serving dual roles. One being the duties as required and outlined here and the duties as the Convention Steering Committee for our club, this means their duties have doubled for this year and will continue to be increased through this time next year. We also encourage people to participate, I just want to make sure that you understand the commitment that will be required for the next year if you desire to seek an office.

The Board of Director's currently meet once a month in addition to the General Members Meetings. As we get closer to convention, the meeting schedule may increase. If you have any questions regarding any of these positions, don't hesitate to ask me or one of the other board members.

#### Convention Update . . .

We (CCCC Board of Directors) have made a great deal of progress with our convention plans and now we would like to hold a planning meeting for the entire club. We will also be inviting the members from the Huron Valley Club that have so graciously offered assistance, the Siebels from KCC, and the Biksacky's from RCWM. The meeting will be November 6 in Lansing, followed by an evening at Swartz Creek Raceway.

To provide a brief update as to where we are at this time I would like to recap our progress.

- A contract was completed and signed with Shanty Creek Resort for the period of 7/7 15, 2000. This includes sleeping rooms and meeting room space.
- The Convention Brochure has been completed and distribution has begun.
- The front cover of the brochure appeared on the back cover of the summer issue of Blue Bars. This has generated further interest. As people contact me, I am mailing brochures.
- Our web site will have the brochure posted.
- The low speed event will be held on Tuesday, July 11 at the Antrim County Airport. We are currently working with the local officials in Bellaire to confirm our use of the facility.
- Drag Racing has been added to the agenda for Thursday, July 13. We are working with Mid-Michigan Motorplex for this event.
- We are in the process of finalizing our plans for the registration information and articles to be included with the registration package.
- We have received a commitment from the Turtle Creek Casino for the sponsorship of Sunday night's activities. (Road Tour and charity car show). Shanty Creek personnel are working out the details with the casino.
- Theme parties have been decided as follows:

It was determined that there were 6,000 Corvettes and 60,000 people who attended the Labor Day Celebration in Bowling Green over the holiday weekend.
