Capital City Corvette Club Governors Report of November 10, 2001 Meeting

The results of the National elections were announced. In the only contested race Jim Adrian won over Pete Dawley for the position of Vice President of Competition.

A representative from K & K Insurance was present to answer questions regarding the NCCC insurance. As I understood one item of discussion, non-NCCC members are not protected by the National insurance policy even though they may be a member of a NCCC club. The K & K policy is there to protect NCCC, its member clubs, and its individual members. This sounds like a very good reason to be a NCCC member in today's sue happy society.

Treasurer Jay Hommer presented his report. An auditor presented the results of his audit. The auditor made a few suggestions regarding club bookkeeping records. Currently the convention treasurer is using Quicken software. It was suggested that a copy of Quick Books Pro be purchased and provided to each Convention Treasurer for their record keeping. This will match the software that Jay uses and will facilitate the import and export of financial records. NCCC will have an estimated loss for 2001 of \$25,000 to \$35,000 mainly due to the switch from a cash basis of accounting to an accrual basis.

Convention Steering Committee Chairman Jim Harris gave a brief report on future conventions. There is a possibility that a proposal for the 2004 Convention in the Minnesota area will be submitted.

Director of Public Relations Laurie "TEX" Schwab reported on the NCCC web site activity. As of November 8th, 99,849 hits were made on the site. Large events (where over 50 entrants are expected) will be listed on the Key NCCC Events page.

Director of Charity Patrick Dolan reported that the NCCC Scholarship levels will be raised from \$500 to \$750. The raffle tickets for the 2002 raffle are now available. The green sheet in your NCCC renewal packets will allow you to purchase tickets at the 5 for \$25 rate. All other tickets are to be sold (or purchased) at \$10 each. The proceeds from the 2001 raffle afforded a donation of \$15,000 to the National Kidney Foundation.

Vice President of Competition Roger Mitchell gave his final report. There are several updated Drag Records as follows: Group 2C is now 11.93; 2E is now 12.96; 1D is now 14.10; 1E is now 13.58; L1D is now 14.22; and L1E is now 13.81. Record Drags will be held next year on May 26 in Oklahoma City, Oklahoma; July 11 at the NCCC Convention in Indianapolis, Indiana; and September 29 in Tulsa, Oklahoma.

Business Manager Dan Skinner gave his report. Dan thanked everyone for their thoughts and kind words due to the very recent loss of his wife to cancer. Dennis Patrick, the keeper of all NCCC trinkets (patches, stickers, license plate frames, etc.) had patches made with the 2001 Convention logo. For some reason they were not provided as part of the convention packets. He has some available for \$3 each or 2 for \$5.

Vice President of Membership Paul Bohannon passed out his reports.

The Editor was not present but it was stated that the Convention Issue of Blue Bars is mailing now. The deadline for the next issue is December 1.

Deb Murphy spoke about the happenings with the National Corvette Museum. A caravan consisting of all 50 years of Corvettes will take place in 2002. Another caravan will take place in 2003 commemorating the 10-year anniversary of the museum. Check the web site www.nationalcorvettecaravan.com for more info.

Deb also gave a wrap up of the 2001 Convention. There were over 800 attendees including day passes. Financially there were was \$5,292 left over with \$4,974 owed back to National plus over \$3,000 in other reimbursements owed back to National. She stated that it looks like there will be a "deficit" of \$2,683. Over \$30,000 was spent on beverages alone which was \$10,000 over budget.

Isn't it funny how the word deficit sounds better than LOSS! It's uncomprehensible to me how there could be a loss with so many people attending even though they provided so little as compared with what we did at the 2000 Convention. If they would have had to pay for NCCC officers' rooms and purchase Convention patches like we did, they probably would have lost much more than we did at our Convention. Maybe now people at the regional and national level will realize what an excellent job Loretta and the rest of our club did with the 2000 Convention. Somehow I think they won't. Enough of my editorial on this subject.

The 2002 Convention Chairman reported on the progress of next year's Convention. Registration forms will be in the NCCC renewal packets. Hotel reservations must be made through convention registration. There will be no trailer parking at the hotel. Parking will be available at the State Police post I-mile away. Non-NCCC members who register for convention will be allowed to enter competition events. I have a listing of the events dates and places if you would like to know them. One that I am looking forward to is the opportunity to drive a lap around the famed Indianapolis Motor Speedway on Monday.

Holiday Treats

Candy Cane Cookies

Ingredients

1/2 cup butter or margarine, softened

1/2 cup shortening

1 cup confectioners' sugar

1 egg

1 1/2 teaspoons almond extract

1 teaspoon of vanilla

2 1/2 cups flour

1 teaspoon salt

1/2 teaspoon red food coloring

Directions

Heat oven to 350. Mix thoroughly butter, shortening, confectioners' sugar, sugar, egg, and flavorings. Blend in flour and salt. Divide dough in half; blend food color into one half. Shape 1 teaspoon dough from each half into 4-inch rope. For smooth even ropes, roll them back and forth on lightly floured board. Place ropes side by side; press together lightly and twist. Complete cookies one at a time. Place on ungreased baking sheet; curve top of cookies down to form handle of cane. Bake about 10 minutes or until set and very light brown. If you wish, mix 1/2 cup crushed peppermint candy and 1/2 cup granulated sugar. Immediately sprinkle cookies with candy mixture; remove from baking sheet

Hard Tack Candy

Ingredients

3³/₄ cups of sugar

11/2 cups of white karo syrup

1 cup of water

food coloring

flavor oils (These can be found at specialty candy or gourmet stores)

Directions

Mix sugar, karo, and water in medium to large pan on the stove.

Using a candy thermometer, cook until the temperature reaches 310°. Immediately remove from heat; pour in one bottle of flavor oil and desired amount of food coloring, stirring both in quickly.

Now pour onto a teflon-type cookie pan and let cool completely.

Once cooled, hold over a large container and whack it with a knife!

Continue to break large pieces until you have desired size for eating.

These are a couple of our favorites. We hope you enjoy them too.
