From the President . . .

This month I want to talk about our General Membership Meetings. First of all, I want to apologize to anyone who may be unhappy about how the meetings are run.

In my way of thinking, the monthly meetings at the Point After are one way the membership can become informed on the happenings of the club. While our recent growth, and therefore our attendance at the meetings, is something to be proud of, it can be very difficult to conduct an organized meeting. One problem that has developed, and I take full responsibility for not controlling it, is that there are many conversations going on while officers and members are giving reports and other input. With other conversations going on, it can be nearly impossible for those members and guests to hear what is being said.

Our board members volunteer their time to run the club. As an officer, it is very discouraging when you are trying to give reports to inform the membership, and there are several other conversations going on while you are speaking. It is disrespectful to the speaker, as well as to those who are trying to hear.

I know the meeting room is not ideal for sound. I am working on getting a PA system to use at the meetings so that people can hear. Still, this will only work if people are willing to pay attention to what the speaker, whoever they may be, has to say.

It is not my intent to make the meetings just a boring business meeting. In order for the club to conduct its business as quickly and orderly as possible, I ask that we keep our socializing to before and after the meetings. If you have any input, viewpoints, or comments, just raise your hand and you will be allowed to speak so that everyone can hear what you have to say.

I know it is distracting to have the wait staff taking and delivering orders during the meeting.

This is why I ask that if you want to eat at the restaurant, please try to arrive in time to order by 6:30. I know this is not possible for many of you, so I will be speaking with the management on how best to handle orders after the meeting starts. Hopefully we will find a way which will cause as little disruption as possible.

It has been suggested that maybe we shouldn't be holding our meetings at a restaurant. Years ago, the club held its meetings at a UAW hall and went out to eat after. What happened was that many who went to the meetings did not go out after for a variety of reasons. It works much better having the meetings at restaurants because it gives the members a lot of social time before and after the meeting to get to know one another. I'm sure this contributes to the family-like atmosphere I see within the club.

It has also been suggested that the board handle more of the "little" issues at the board meetings and just inform the members of the decisions at the membership meetings. I certainly agree, especially in the case of the name badge issue which took so much time at the last meeting. Obviously, the membership needs to have a chance to give their input on many "bigger" issues. I feel that last month's talks about the newsletter and copy machine issues brought up a lot of good ideas that may not have been thought of at a board meeting. I will act on this suggestion to try and make the membership meetings more relevant to the interests of those in attendance.

Again, I want the meetings to continue to be fun and informative, just a little more organized and efficient. Let's work together to make the meetings better for everyone.

SOCIAL: Janet Johnston is circulating a sign-up sheet for Corvette Crossroads. Brad and Carrie Hutton are hosting a hayride on September 20, 2003. Providing brats. Bring a dish to pass. Don and Carol Armstrong are hosting a color tour on October 11, 2003. More information will be available next month. Janyce said the arrangements for the Tour of MIS with the Model A Club did not work out. Janyce said we're still awaiting a reply from MSU regarding the arrangements for the October 3 & 4 homecoming festivities. More information later. Janet Johnston advised everyone that if they want to organize an activity to contact her.

POINTS: Don Armstrong indicated all points have been updated and are posted on our website, as well as in our newsletter.

TREASURER: Colleen thanked everyone for their mini-golf attendance. She stated 14 vehicles have pre-registered for the Zoo show. We received a \$30 donation from a lady whose Corvette was sold through our club. Account balances were read.

EDITOR: Phil provided report in Cindy's absence. August 26 is the deadline for submitting information for the next newsletter. Cindy will not be running for re-election.

COMPETITION: Rich Bratschi had no news to report.

GOVERNOR: Don Johnston advised the region meeting was held last night, August 5, 2003. Bylaw amendments have been proposed. He and Phil Hanses will review them and present them for discussion at next month's meeting.

PRESIDENT: Board meetings will be held at Simon and Gloria Reiffer's home for the remainder of the year. August board meeting is on August 20, 2003. Check newsletter for future meeting dates. Postage for our newsletter costs approximately \$50 per month. He suggested we might save money by having people pick them up at our general membership meetings. It might be possible to email Phil and let him know whether or not they will pick that month's newsletter up or ask that it be mailed. Discussion only. No motion.

MEMBERSHIP: Jeff McQuade advised we have 108 members as of tonight, 82 adults, 26 FCOA. This includes our newest member, Jeff Mitzel, who joined tonight. Jeff indicated we can buy extra club T-shirts for \$7.00 each – available to members only. He will look into FCOA T-shirts for children. Jeff advised the magnetic badges cost \$156.00 for 100. Engraving is \$.10 a letter. Motion: Jeff moved that the club purchase 120 badges. Everyone who is a member as of tonight will receive one free-of-charge, including the engraving of his/her first name. Janet/Margaret seconded. Lengthy discussion. Phil was not in favor of the club buying badges for inactive members. An amendment was proposed to exclude inactive members, and have everyone pay \$2.00 toward the purchase and engraving prices. After a lengthy discussion, Jeff's original motion was voted on: 18 – yes 15 – no. Original motion passed.

OLD BUSINESS: Phil Hanses says we've sold 23 ads for the Zoo flyers. All are paid except Pres Kool Chevrolet. SECU paid \$125.00 to sponsor the event and will provide 10 trophies and one best-of-show. Evelyn & Jeff and Massman Trucking agreed to remove their names from the flyers/shirts because space was needed. Phil indicated we have about 100 Zoo flyers left. We have 30 trophies ordered plus best-of-show. We're still looking for door prizes. Jeff McQuade indicated we need items for goodie bags. Phil says we have 30-40 items left over from last year. Jeff stated the bags will be put together after the September meeting. Jeff updated everyone on working at Simon and Gloria's house this next Saturday, August 9. Dave Kuempel will organize workers. Let Jeff know if you can come. There will be a potluck luncheon. Phil gave us an update on our copy machine replacement. He is still researching price, warranties, etc. Also, because of the cost of monthly fees, and toner, etc., it is possible leasing one may still be our best choice. Members offered several suggestions; i.e.: electronic newsletters versus hard copy, paying for printing services, updating club's computer software, etc. Jeff Mitzel will assist Phil in his research. Phil Hanses stated he has nothing new to report on club picture. He would like to have it taken this year before everyone stores their cars. Still researching how, when, and where the picture will be taken.

MEMBER INPUT: Gary Brothers invited all members to an August 12th St. Vincent fund raiser. It will be held at Oldsmobile Park. Activities: Six 30-minute baseball games, cheerleaders from area schools, etc. Randy Putman advised us of a CarDone recall on after-market brake calipers stamped: 18-7019, 18-7020, or 16-7019. 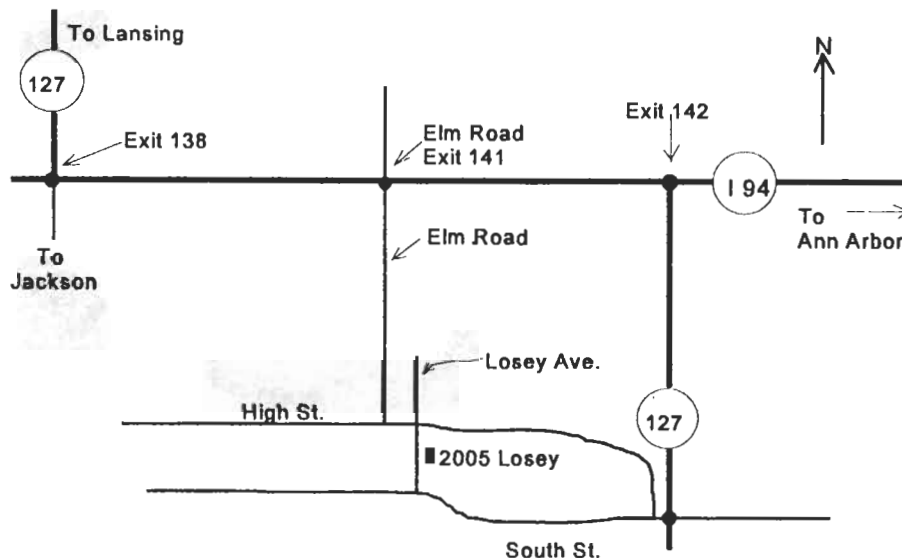

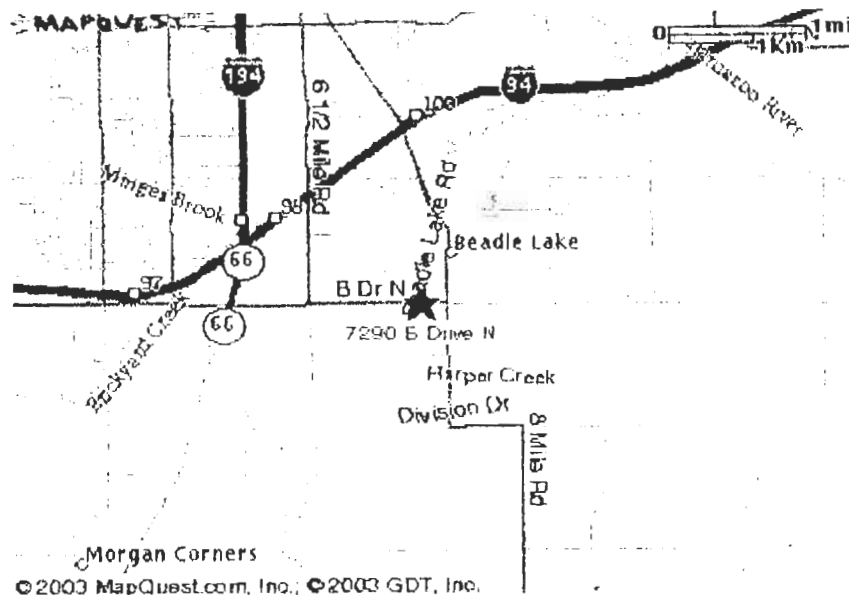

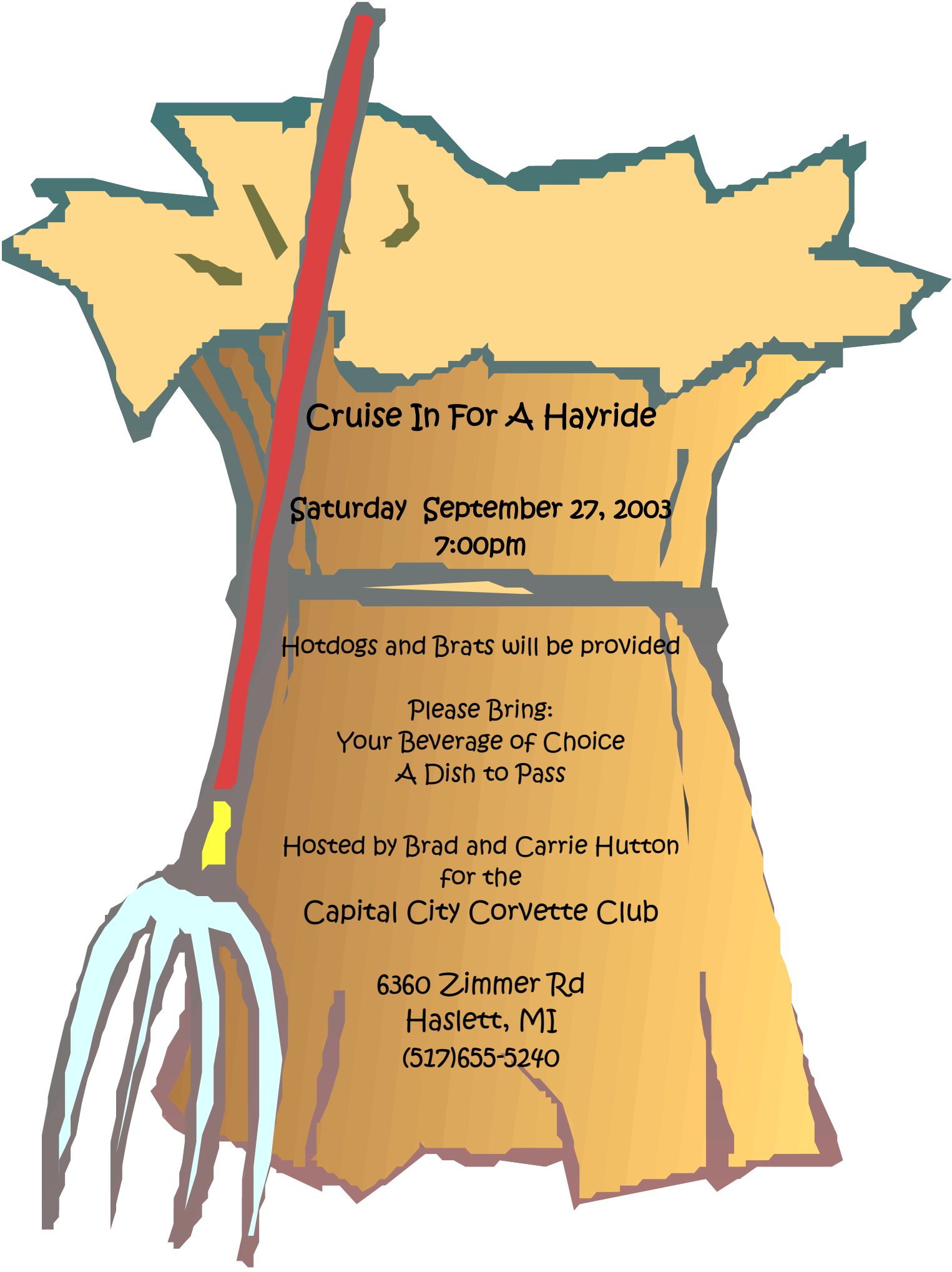
