CAPITAL CITY CORVETTE CLUB
General Membership Meeting – September 3, 2008

President John Bechtel called the meeting to order at 7:05 p.m. He extended a welcome to visitors and members.

Secretary: Sandy Bechtel presented the minutes of the August 6, 2008 general meeting. Carol Putmon moved to approve them as written. Rich Bratschi seconded. Motion passed.

Ambassador: Sandy Bechtel gave a report on the ambassadors' meeting held at the National Corvette Museum during its 14th annual anniversary Labor Day celebration: *Wendell Strode reported that 70+ acres have been purchased for \$1,000,060 to develop a motorplex. A campaign is underway to pay for the land within three years. The motorplex will include a 1.5 road course, a ¼ mile drag strip, and a 2-acre autocross area. A burn-out area may also be included. The motorplex will be used for museum events, club events, driving schools, leased training, etc. *Caravan '09 plans are moving along. Captains choose their own routes. Many clubs and captains have blocked hotel rooms. People are encouraged to book rooms in Nashville for the time being. When local blocked rooms are not reserved, they will be released. (Refer to the museum's website for names and locations of available rooms.) People can then book local rooms and cancel their Nashville rooms. Many volunteers will be needed for the 2009 Labor Day Anniversary Celebration/Caravan. Shuttles will transport people to and from designated parking areas. *Fall/Winter and Caravan '09 merchandise is now available on line. Caravan car flags are only available through captains. *Carl Stover from Georgia won the 2009 Red Corvette Coupe.

Points: Carrie Hutton advised points are updated on our website.

Membership: Colleen Bratschi reported we currently have 119 regular, 1 honorary, and 73 FCOA members. She is now accepting renewals for 2009. She reminded us that your membership must be renewed before you can vote at the November general meeting. If you must vote by absentee ballot, please request one from Shalimar Maynard (517-347-2949 or shalmayn@aol.com) by October 20, 2008.

Social: Kathy Wyma reported that recent events (Bones & Cones, Spartan Speedway Low-Speed, and Corvette Crossroads) were successful. Gloria Reiffer noted 42 members attended Crossroads – 5 won awards. Upcoming events include: September 6th Drive & Dine, September 7th Beekman Center car show, September 14th Horsepower at the Zoo car show, September 20th Paragon open house, September 21st shopping trip to the Frandor Dress Barn (RSVP to Diane Brown by September 14th), September 27th Putmons's BBQ/Hayride/Bonfire, October 11th Drive & Dine, and October 18th color tour. Check our website for event flyers. Kathy indicated we still need a date and prizes for bingo at Tamarack Assisted Living Center. Dave Cripe noted September 7th is the

last 2008 show at Gilmore's Car Museum. There is also a car show in Holt on September 21st.

Treasurer: Carol Putmon reported that all bills are paid under the current approved budget. See her for specific account balances.

Editor: Chris Burke stated the deadline for submitting October newsletter information to her is September 22/23.

Competition: Gary Wyma noted the regional NCCC meeting will be held at LaSenorita's on September 9th. All club members are welcome to attend. He also stated he is trying to schedule the chassis dyno testing event for some time in October.

Public Relations: Bob Maynard had nothing new to report about HAZ sponsors.

Governor/Vice President: Rich Bratschi reported we made almost \$1,500.00 at our low-speed event. Rich also issued a challenge to members to donate money to HAZ.

President: John Bechtel noted that he was recently interviewed about Corvettes by a Detroit News reporter for an article about General Motors' 100th anniversary. The article will appear in the September 16th edition. John also reiterated a person's membership must be current and in good standing to hold an office and/or vote. He requested that if a person is nominated for a board position, that he/she consider the nomination until our October general meeting before declining.

Old Business: Angie Hyde reminded people to pick up their 2008 membership cards from her, if they have not already done so. She also requested old cards people may have so she can place them in an album.

New Business: John Bechtel opened nominations for 2009 board positions. He reminded people that in order to be president, a person must have previously held a board position.

Board Meeting – September 17, 2008

President John Bechtel called the meeting to order at 6:32 p.m. Absent: Shalimar Maynard, Angie Hyde, and Gary Wyma.

Reports:

Secretary: Sandy Bechtel presented the minutes of the August 20, 2008 board meeting. Rich Bratschi moved to approve them as written. Carol Putmon seconded. Motion passed.

Ambassador: Sandy Bechtel stated there is nothing new to report.

Points: Carrie Hutton advised that with the exception of the Spartan Speedway low-speed event, all points are updated on our website. Rich Bratschi noted that problems with information from NCCC are causing a delay in posting those points.

Membership: Colleen Bratschi reported we currently have 121 regular, 1 honorary, and 73 F.C.O.A. members. She has received 19 primary and 15 spousal/companion renewals for 2009. Colleen suggested that \$100.00 be included in next year's budget for the membership position expenses. As chair of the 2009 nominating committee, she noted she is currently contacting nominees to confirm whether or not they will run for office. She is pleased with responses.

Social: Kathy Wyma noted that Jim Balla is taking over chairing our Fall color tour. It will be held on October 11th, and replace the drive & dine previously scheduled for that date. Kathy also explained she is awaiting confirmation from Tamarack to hold our annual bingo afternoon on the second Saturday in November.

Treasurer: Carol Putmon provided balances for all accounts, and noted that all bills have been paid. We are operating within our approved budget.

Editor: Chris Burke had no report.

Competition: On Gary Wyma's behalf, Kathy Wyma noted he is still waiting to confirm a date for the dyno testing at Ram Racing, Saranac, MI.

Public Relations: Bob Maynard stated he will call our advertisers in October so that 2009 renewals can be in by the end of the year. He will also contact Bud Kouts Chevrolet about renewing their sponsorship of our club.

Governor/Vice President: Rich Bratschi reported that it was decided at the last NCCC regional meeting that all clubs in our region will be assessed \$1.00 per member for regional operating expenses (postage, travel, etc.). Rich recommended that our club pay

our assessment from our treasury, rather than pass it along to our members. Future club budgets should include this expense.

President: John Bechtel noted some club members expressed a desire to quickly reschedule our Horsepower at the Zoo car show. A zoo official, however, advised John this would not be possible because the zoo is expected to be closed through next weekend (September 21) because of flooding, and it is not available September 28th or October 5th. Based on this information, Bob Maynard moved to cancel the show. Carrie Hutton seconded. Motion unanimously passed. Show sponsors and pre-registrants will be contacted and asked if they wish to have their money refunded or donated to the zoo. Trophies and dash plaques will be paid for and used next year. (There will be an expense to replace the brass plates on the trophies with 2009 information.) We will have a silent auction for a couple large door prizes, and also auction off six donated Dean Trailways Soaring Eagle Casino round-trip bus tickets. All proceeds will be donated to the zoo.

Based on John's past request to form a charitable donations committee for our holiday season, Bob Maynard, Rich Bratschi, and Sandy Bechtel agreed to do so. Because donations are down for so many local non-profit organizations, increasing our \$900.00 budget to \$1,500.00 was discussed. If our membership approves such an increase, it was suggested the money be divided three ways: \$500.00 Lansing Food Bank, \$500.00 Red Cross, and \$500.00 VFW National Home for Children. As in past years, personal donations will also be collected and included with the club's donations. Further discussion will take place at the October general membership meeting.

John noted Patty DeNike contacted him about the possibility of club members participating in a house Extreme Makeover taking place soon in Lansing. Information will be forwarded to our membership so interested people can contact the organization.

Old Business: None

New Business: Chris Burke noted that because she will not be attending the October general membership meeting, it will be necessary for John to print and distribute agendas.

Member Comment: None

Adjournment: Carrie Hutton moved to adjourn. Chris Burke seconded. Meeting adjourned at 8:15 p.m.

Nominations for the 2009 Board of Directors will take place at the September and October membership meetings. In preparation, all members are encouraged to review the CCCC By-Laws for a description of the duties of club officers.

To help the process flow smoothly, a nomination committee will be formed. This committee will contact everyone nominated. At this time, we are looking for 3 or 4 members to serve on the Nomination Committee. If you are interested in serving, please contact any one of the current Board Members. In addition, all members are encouraged to attend the remaining Board Meetings. This is a great way to learn more about the Board positions, and ask questions of the outgoing Board Members regarding their duties.

We ask that you do not turn down nominations at the meeting, but take time to think it over. A member of the committee will call those nominated to ascertain willingness to accept the nomination. Please be assured that your name will not go on the ballot if you inform the committee member that you don't wish to run for a board position. If nominated for more than one position you can let the committee member that contacts you know which position(s) you would be interested in serving. Members may also contact a committee member directly with any questions.

The election of 2009 board members will take place at the November membership meeting. Absentee ballots will be available.

Nominations / Election: Nominations for the 2009 Board of Directors of Capital City Corvette Club are open at the September and October general membership meetings. The election takes place at our general membership meeting on November 5.

If you will not be at the November meeting, absentee ballots are available by contacting Shalimar Maynard by phone or at the email address on our membership list. Requests must be made prior to October 30 in order to allow the necessary time for the US Postal Service to process the mail.

President: The President shall perform such duties as shall be designated by the Board of Directors. The President shall preside at all meetings of the Members and the Board of Directors. The President may call special meetings of the Members of the Board of Directors, and may exercise special authority as noted elsewhere in these by-laws. The President shall be the Chief Executive Officer of the Club.

Governor / Vice President: The Governor shall perform such duties as shall be designated by the Board of Directors and consistent with the NCCC Guidelines to Governors document. The Governor is responsible to ensure the Club remains in Good Standing with NCCC by at minimum ensuring voting proxies are in the hands of the Regional Executive prior to every National Governor's meeting not personally attended. As directed by the Board of Directors the Governor is encouraged to attend at least two of the scheduled meetings established by the National Council of Corvette Clubs and shall attend at least 75% of all the Michigan Region Meetings. The Governor shall present all activities or communications regarding items for publication, competition, membership, and social functions to each respective Officer for their information. The Governor shall present a written report detailing information discussed at the NCCC Governors Meetings in the Club newsletter annually. The Governor shall also serve as the Club's Vice President and shall accept the duties of the President during his/her absence.

Competition Director: The Competition Director shall perform such duties as shall be designated by the Board of Directors. The responsibility of all competition events sponsored by this Club and/or coordinated with any other organization pertaining directly to competition is appointed to the Competition Director. The Competition Director shall attend at least 75% of all the Michigan Region Meetings and report back to the General Membership. It is the responsibility of the Competition Director to perform the expected duties governed by the Michigan Region. Sanctioned events, times, dates, and locations must be made readily available in the newsletter and at the General Membership meeting to all Club Members within a proper time prior to that said event. The Competition Director is ultimately responsible for the competition points program. The Competition Director and Points Director are responsible to select and purchase the year-end awards and/or patches.

Editor: The Editor shall perform such duties as shall be designated by the Board of Directors. It is the Editor's job to assume the responsibility of gathering, organizing, and providing all pertinent data and information in a monthly newsletter. The newsletter shall contain reports from each Officer with minutes from General Membership, Board, or Special meetings and any other information of interest to the Membership as a whole. It shall be published within the last day of the preceding month for the month of intended publication. The newsletter shall be sent or made available to every Primary Member in the Club. Extra newsletters may be printed for promotional use by the Membership and Public Relations Director and any Club Member.

Membership Director: The Membership Director shall perform such duties as shall be designated by the Board of Directors and assume the responsibilities and encourage the recruitment of New Members, collection of membership dues, submitting to the Club Governor the NCCC and Club renewals, and keeping Membership records up-to-date. The Membership Director shall also handle the promotional perks given out by NCCC/CCCC to New Members. The Membership Director is responsible to have published in the newsletter, twice a year, a membership list with addresses, email addresses, and phone numbers.

Points Director: The Points Director shall perform such duties as shall be designated by the Board of Directors. It is the duty of the Points Director to provide a list of possible points to be earned and to compile such points. Monthly up-to-date points are required to be made available to the General Membership. A breakdown of Points shall be made available to the General Membership at all General Membership meetings. The Points Director and Competition Director are responsible to select and purchase the year-end awards as budgeted.

Public Relations Director: The Public Relations Director shall perform such duties as shall be designated by the Board of Directors to promote Club participation in Civic Activities and to enhance the image of the Club and its events. The Public Relations Director is responsible for putting up promotional displays at all Club functions involving the public. This position is also responsible for coordinating solicitation of advertisers for the newsletter.

Secretary: The Secretary shall perform such duties as shall be designated by the Board of Directors. The Secretary shall attend all meetings of the Members and Officers and shall record decisions, actions to be undertaken and votes in a book kept for that purpose. In the absence of the Secretary, another Member shall be chosen by the President to perform said duties pro tempore. It shall be the responsibility of the Secretary to handle Club correspondence and make it available to the Membership.

Social Director: The Social Director shall perform such duties as designated by the Board of Directors and shall assume the responsibilities of the coordination of all Club Social functions. The Social Director shall make readily available in the newsletter, Web site and General Membership meetings, times, dates, and locations of all social events. At club meeting he/she shall congratulate members on the occasion of such events as birthdays and anniversaries.

Treasurer: The Treasurer shall perform such duties as shall be designated by the Board of Directors. The Treasurer shall have custody of all monies, debts, and obligations belonging to the Club and shall make all payments of the Club debts upon the approval of the President and/or the Board of Directors. All checks, drafts, and other orders for payment of money shall be signed in the name of the Club by the Treasurer and one of the three other Board Members specified by the President and approved by the Board of Directors. A report of the financial status of the Club monies shall be given at each regular meeting and whenever requested by the President. The Treasurer shall at minimum maintain the Clubs records in accordance with Generally Accepted Accounting Principles. The records should be in a format auditable by the IRS and subject to annual review by a Club Audit Committee composed of members that may include the past Treasurer, or any member that has bookkeeping or accounting experience. The Club financial records must include at minimum an annual operating budget and year to date variances from budget, an annual income statement with separate schedules for overall operations, and for each fundraising event with sufficient detail to permit the annual budgeting process.
