Reports:

Secretary: Sandy Bechtel presented Carol Putmon's minutes of the January 21, 2009 board meeting. Ted Lasher moved to approved them as written. Simon Reiffer seconded. Motion passed.

Ambassador: No report.

Points: Ted Lasher advised current points are posted on our website. He indicated he would like to reword a portion of our points information for clarity purposes. He will present the change at the March board meeting.

Governor: No report.



NCCC Convention

This year the convention takes place August 8-14 in Colorado Springs, CO. It looks to be an extra special convention as it is also the 50th anniversary of NCCC.



There are a lot of things to do at convention and you don't have to be a competitor to enjoy it. Since CCCC hosted the NCCC convention in Bellaire, MI (2000) we have attended conventions in Bowling Green, KY (2001), Indianapolis, IN (2002), St. Cloud, MN (2005), and Nashville, TN (2007). The Michigan Region hosted one in Lansing in 1994. We joined too late to attend but the public was invited to a parade and car show and we won the dance contest!

A hospitality room with all of the pop and beer you care to drink is available every day. Light snacks are usually provided as well. The hospitality room allows you to kick back and visit with other NCCC members from around the country. In addition, a Corvette Mall is set up with many vendors offering you their wares. Both rooms are open during the day, sometimes right up until the evening party. When space allows, the hospitality room and Corvette Mall are located in the same room.

There are many competition events during convention. To participate in any of them you need to sign up on your registration form. There are high speed, low speed, and drag racing events. We have always attended as spectators and enjoy watching the top NCCC racers from around the US compete. You'll see many of the racers that come to Spartan Speedway out on the tracks at Convention.

Both people's choice and judged concours events are on the schedule. You will also have the chance to participate in a rallye and a funkhana. The rallye usually provide the opportunity to spend a few hours driving around trying not to get lost, but getting to see some beautiful countryside. It's anybody's guess what kind of fun you might have in the funkhana! We've seen a blindfolded driver in a golf cart being directed by their partner around an obstacle course. We've seen Corvettes driven on a golf path to game stations. We've seen funkhana's done on foot and even on a tricycle. They almost always involve some type of game or skill and we have never seen two alike. Watching can actually be more fun than participating.

Almost every night is party night at convention, always with a theme. You'll find everything from live entertainment to Karaoke. Some really great door prizes are given out during the parties – including several full sets of tires.

If you decide to go, be sure to sign up for the full package – not the day passes. Parties usually aren't included in day passes. I hope that many of you will be able to attend the NCCC Convention this year. We plan to go!!! It sounds like a blast! Ask us if you have any questions.

I'm sure someone will find fault with this method, but it works like a champ, per Mr. Flintstone.

Procedure for Detailing Under the Hood

1. Start the car and let it idle for 5 minutes to warm it up and then shut it off.
2. Using a vinegar-based glass cleaner like Windex, amply spritz the beauty covers, radiator shroud, hoses, etc. The more the better.
3. Close the hood and go drink a beer.
4. Take your garden hose and wash off the glass cleaner. ****See note below.****
5. Spray Armor All or equivalent over those same surfaces. Avoid the belts and as many wires, etc. as you can. Use a lot on the fender covers.
6. Close the hood and wash the rest of the car. Keep the hood closed for at least 10 minutes.

When you open up the hood it will look brand new, trust me. I got this tip from a well-known detailer who has won enough shows to make a believer out of me.

I don't know if this will work on really dirty engines. You have to keep up on the car for this to work. There also was a concern with a Service Bulletin concerning washing the engine. I use very little water when I do it.

****NOTE**** *When I say spray down the engine compartment with the hose, I'm talking about very gentle, barely more than a spritz. The idea is to get the visible surfaces wet, not flood the electronics.*


