



Social Time & Dining started around 5:30 P.M.

President: Craig Iansiti called the general membership meeting to order at 6:59 P.M. Craig commented on the good turnout that night.

Craig gave personal congratulations to Pat & Dave Cripe on their 26-year anniversary and forwarded an invitation to members who wanted to attend a retirement/birthday celebration for Joe Platte.

Craig proceeded with the introduction of **Sherri Graham**, *Executive Director* and **Jennifer Hovartin**, *Special Events Coordinator* of the **Potter Park Zoo**. A presentation of Horsepower at the Zoo or 'HAZ' proceeds was given to them.

Ms. Graham thanked members and explained that the zoo depends on private donations. She was thrilled to announce that the millage had passed the previous night. She went on to explain the Zoological Society's function. She spoke of current improvements to the zoo such as the rhino exhibit and the North American part of the zoo. She also commented on the improvement of the veterinarian hospital.

Ms. Hovartin the Special Events Coordinator, told of the Wonderland of Lights exhibit running Thursdays 5 P.M.-8 P.M. November 26-December 26. She told of other news such as the Snow Leopard flown in to the zoo for breeding purposes. She went on to say there is also a rhino to mate. The winter hours for the zoo are 10 A.M. until 4:00 P.M. with the exception of the Wonderland of Lights extended time.

Craig spoke of the holiday gifts to be given to the Greater Lansing Food Bank. Bob Maynard volunteered to spearhead that drive and told members of the tax incentives available to donors. She reminded people who were coming to bring desserts and prizes. She also reminded members of the upcoming (November 13) breakfast at Zues'.

She also reminded people to get reservations and money in by November 20 for the upcoming Holiday party at Coral Gables. She reminded people about the 'Dirty Santa' gift exchange.

Members were reminded of Winterfest to be held at City Limits Bowling Center in Mason on Saturday, January 8. Money needs to be in by January 5.

November birthdays were acknowledged.

Governor: Terry Burke informed group of the upcoming meeting he would attend regarding rule changes.

NCM Ambassador: Sandy Bechtel was not present.

Board Meeting - November 17, 2010

Social Time and Dining began around 5:30 P.M.

President: Craig Iansiti called meeting to order at 6:30 P.M. Craig welcomed new Board Members and Appointees as well as returning members.

Craig introduced the "Conquerors" 3 of the 5 members of the oldest and smallest car club in Michigan. These men, Ray DeBar, Jim Gates, and Bill Pierce, have been responsible for very successful indoor car shows during the past 50 years. They took turns explaining the differences between indoor and outdoor car shows. They emphasized that their shows have not been open but by invitation only with cars essentially having to try out for the opportunity to be included in the show.

They essentially are looking for clubs interested in helping put on a show in the near future. They answered Board Member's questions about what it is they are looking for in a club's participation. They said that the show included a variety of cars ranging from classic, show, and antique to hot rods. Although the show is invitation only with very strict criteria, there is an entry fee charged to all participants.

Board members wanted to know what all would be expected from our club and wanted to know how the show is advertised, what venue would be used, what time of year would the show be held, etc, etc.

It was decided that the board needed to think about the involvement and discuss with general membership before they would commit to be a part of the car show.

Secretary: Connie Britz asked for additions and/or corrections to the October meeting minutes. The minutes were approved as the draft appeared in the last newsletter.

Treasurer: Mike Britz presented new budget. After some revisions, the board voted to accept proposed budget. Mike will send the approved budget to board members before the January meeting where it will be presented.

Points: Ted Lasher indicated points are updated on website. Ted also commented on his investigation as to whether information articles in the newsletter were in violation of any copy write laws. It was determined that no copy write laws have been violated. Scott has followed guidelines and credited all sources.

Membershhip: Angela Hyde updated roster includes 98 members, 1 honorary, and 69 FCOA's. However, currently the renewals number 81 members, 1 honorary, and 69 FCOA's. It was determined that for this time of year it was a good number. Angela would send a membership roster electronically to all members twice a year --once in January another in June. Competition: Rich Bratschi picked the weekend of July 30 and 31 for low-speed event at Spartan Speedway to be run with Jackson Corvette Club. The cost of the Speedway has risen \$25 from last year's price. The Region Banquet will be held on April 9th.

The region decided not to act on any rule book changes for the time being.

The Jackson Corvette Club will set up an infield car show on or around July 17 and would like for our club to help.

Public Relations: Simon Reiffer has sent letters to current newsletter advertisers. Thus far he has 4 responses. Bud Kouts has agreed to sponsor the club again for the 2011 year.

Social: Carol Putmon reported that 33 people had already signed up for the Holiday Party to be held Saturday, December 1 at Coral Gables Restaurant. Refer to memo sheet or flyers for activities such as breakfast at Spud's on Saturday, December 11 and Winterfest at City Limits in Mason on Saturday, January 8.

Governor/VP: Terry Burke not in attendance

NCM: Gloria Reiffer received approval to register the domain for the website for the next 5 years. She said the price for ATT will be the same price as we have paid in the past.

Hearts & Flowers: Julie Lasher was not in attendance however, she did send a card to Vic Smith as he is experiencing some health problems

Historian: Angela Hyde indicated her annual report will be in the January newsletter.

Quartermaster: Randy Putmon told members the trailer is put to bed for the season. Randy did inquire what to do with the CD player which is not performing well. Craig said he has a friend who will look at it and evaluate it.

Colleen Bratschi told members she and Rich would donate 5 pumper coffee pots which can be kept by the quartermaster.

Kim Keith, who will be director of Points for the 2011 season, suggested revisions to points system to encourage new members. 
