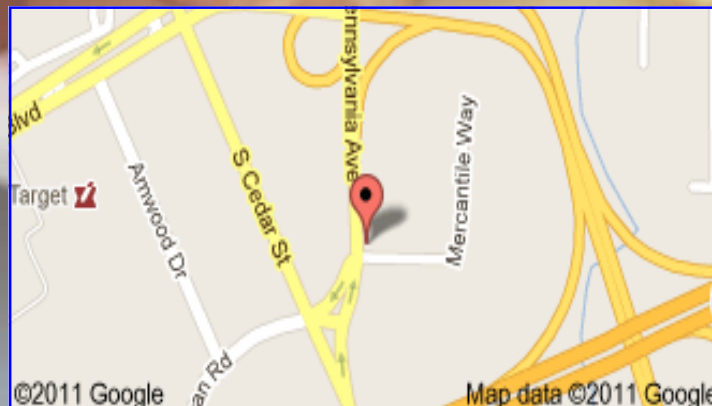

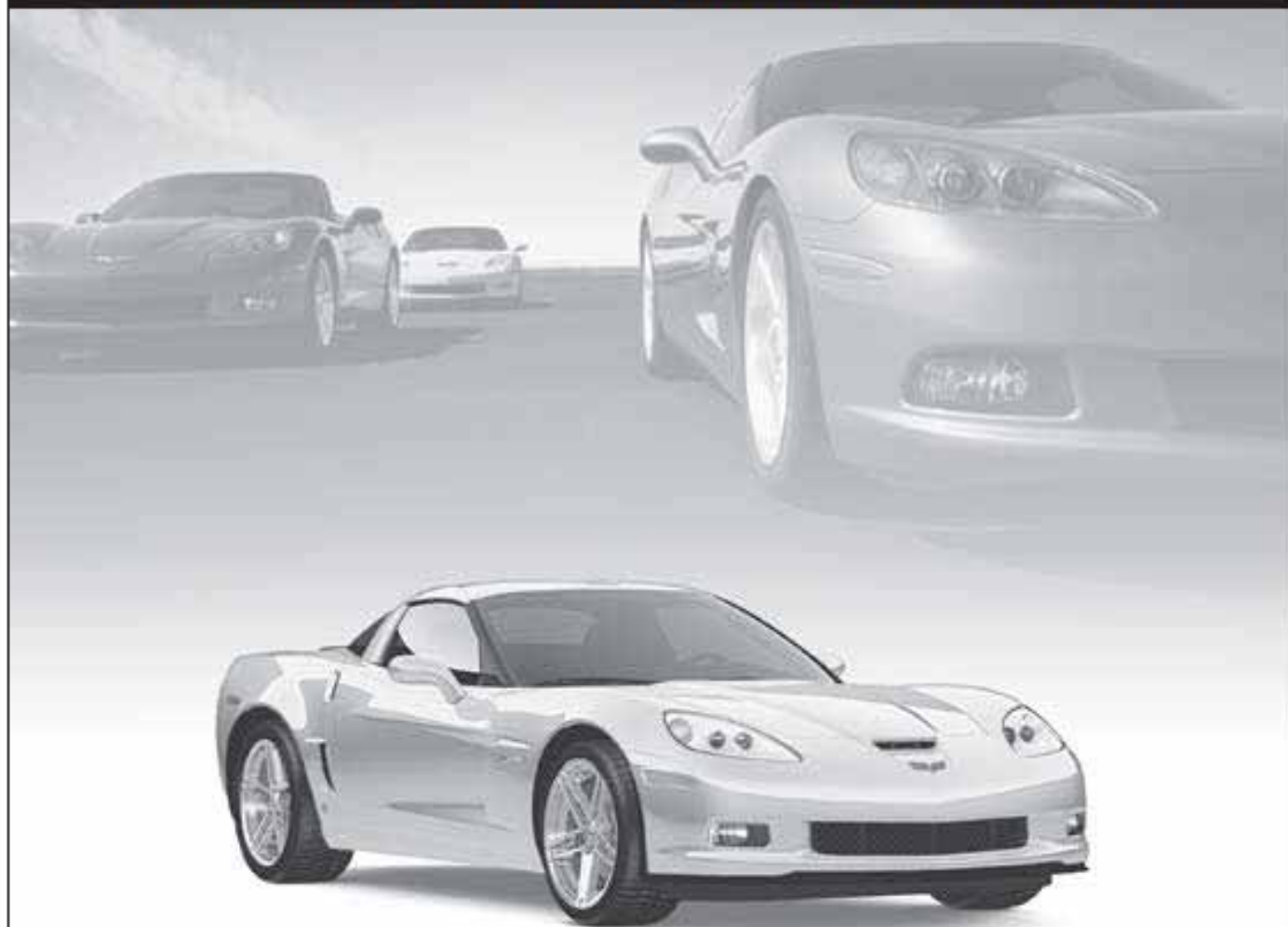

The Greater Lansing Food Bank is a non-profit organization that provides emergency food to individuals and families in need in Ingham, Eaton, and Clinton counties. The Food Bank annually serves tens of thousands of people, many of them seniors and children. Recipients also include the "working poor," those individuals who are employed but don't earn enough to meet housing, health, transportation and food needs.

In 2005 Bob Maynard brought the needs of the GLFB to our members and asked us to help with monetary donations at our annual holiday party. Since 2005 CCCC members have donated close to \$10,500, with another \$3,000 coming from club funds. Bob will accept checks, made out to the Greater Lansing Food Bank, at the holiday party again this year. We will also be collecting canned goods and boxed items to donate. No glass jars or home-made items can be accepted.

Michigan offers an income tax credit that allows reclamation of up to 50% of monetary donations to Michigan food banks. For instance, a donation of \$100 provides you with a tax credit of \$50. Couples can donate up to \$400 for a tax credit of \$200 on your State return. Contributions are also deductible on Federal tax returns!

Services provided by the Greater Lansing Food Bank...

- **Emergency food orders, which include enough non-perishable food to last a family for six days.**
- **The Food Movers program that rescues perishable food from restaurants, commercial kitchens, bakeries, and grocery stores and delivers to our network of pantries and agencies and subsidized housing complexes.**
- **Packs for the homeless, which include food and items such as paper plates and can openers needed by individuals without a residence.**
- **The Garden Project that provides support to home and community gardeners, which includes providing seeds, plant starts, tools and volunteers for gleaning projects.**
- **Open food distribution at Neighbourhood Partnership Program sites & Mass Food Drops (taking food into surrounding communities).**
- **Vouchers for the purchase of dairy and fresh produce.**
- **Financial support to human service agencies for the purchase of food.**

Did you know... The GLFB had a string of bad luck in 2011. Catalytic converters were stolen off their trucks in the spring and then their freezer broke down during a heat-wave causing massive food spoilage. This was followed closely by a lightning strike near their facility and the theft of 7 tires off their trucks! In mid-August their Food Movers refrigerated truck was stolen and then destroyed by fire. Vandals then threw a chunk of metal over their fence and smashed the windshield of their Garden Project truck. Through all of these challenges, they never lost focus on feeding needy families in our community. Let's do our best to help the GLFB as they reach out to help others. **AN AMERICAN
REVOLUTION**

The Steuben Story



Unlikely as it may seem, a group of young men from Lansing, MI who drove Corvettes were honored to receive a crystal bowl in 1961 and again in 1962. The connection between glass and fiberglass goes back to 1903 in New York. Steuben Glass Works was incorporated in 1903 by Thomas G. Hawkes and Frederick Carder. Together they specialized in cut glass and colored glass pieces. The company was purchased by Corning Glass Works around the time of World War I and Frederick Carder became Managing Director of the Steuben Division. In 1933, Arthur A. Houghton Jr. became president and he was joined by architect John M. Gates and sculptor Sidney Waugh. Together they created a unique

formula for prismatic crystal with exceptional refractive and reflective qualities.

A store was opened in New York City and Steuben crystal pieces became known for their beauty and stunning designs. Steuben crystal was presented to Queen Elizabeth for her wedding by President and Mrs. Truman which started a tradition of U.S. Presidents giving Steuben pieces as the gift of state. President Eisenhower gave it to His Excellency, Juscelino Kubitschek, President of Brazil. President Nixon gave a gift of Steuben to Premier Chou En-Lai on his first visit to China. Prime Minister Lester Pearson was given a piece by President Johnson to commemorate Canada's centennial in 1967. President and Mrs. Reagan gave a crystal bowl as a wedding gift to Prince Charles and Princess Diana. It was also the royal wedding gift presented in 1993 by President Clinton to Prince and Princess Hirohito of Japan. Other famous recipients have been Martin Luther King, John D. Rockefeller III, Colin Powell and Norman Schwartzkopf.

Corning Glass had begun researching a new material called fiberglass. They began a joint venture with Owens-Illinois and in 1938 incorporated as the Owens-Corning Fiberglas Corporation. GM Designer Harley Earl had seen a car made from the new material and was impressed with the shapes and flowing lines that could be achieved with it. When Earl began working on the Opel project, he knew that



he was facing a short development and build schedule. Using fiberglass instead of steel would allow him to keep costs down and meet his deadlines. Corvette became the first mass produced car to utilize fiberglass body panels.



Owens-Corning Corporation was eager to promote this new sports car with the fiberglass body. The company still had a close relationship with Corning Glass and its Steuben Division, so when it came time to bestow an award that signified excellence, it turned to Steuben crystal. Owens-Corning gave this award to the Corvette club that they felt had done the most to promote and enthusiastically support the Corvette hobby. In 1961, Owens-Corning representative, Oakley Sovereign, came to Lee MacGillivray Chevrolet in Haslett, MI to present the Capital City Corvette Club with the Annual Recognition Award for the outstanding club of the year. The club was given this award again in 1962. Owens-Corning continued to support the Corvette by sponsoring two young racers from Detroit, Tony DeLorenzo and Jerry Thompson who won many SCAA races in their Corvettes.

Corning Inc. sold the Steuben Division to Schottenstein Stores Corporation in July 2008. On September 15, 2011, Schottenstein announced the closing of the Steuben factory in Corning, NY. If you have not done your Christmas shopping yet, there is a selection of wonderful Steuben pieces on sale at their website. It is fitting that the crystal that was world famous for its dramatic lines and unique qualities would be used to signify all that is excellent in the Corvette realm.

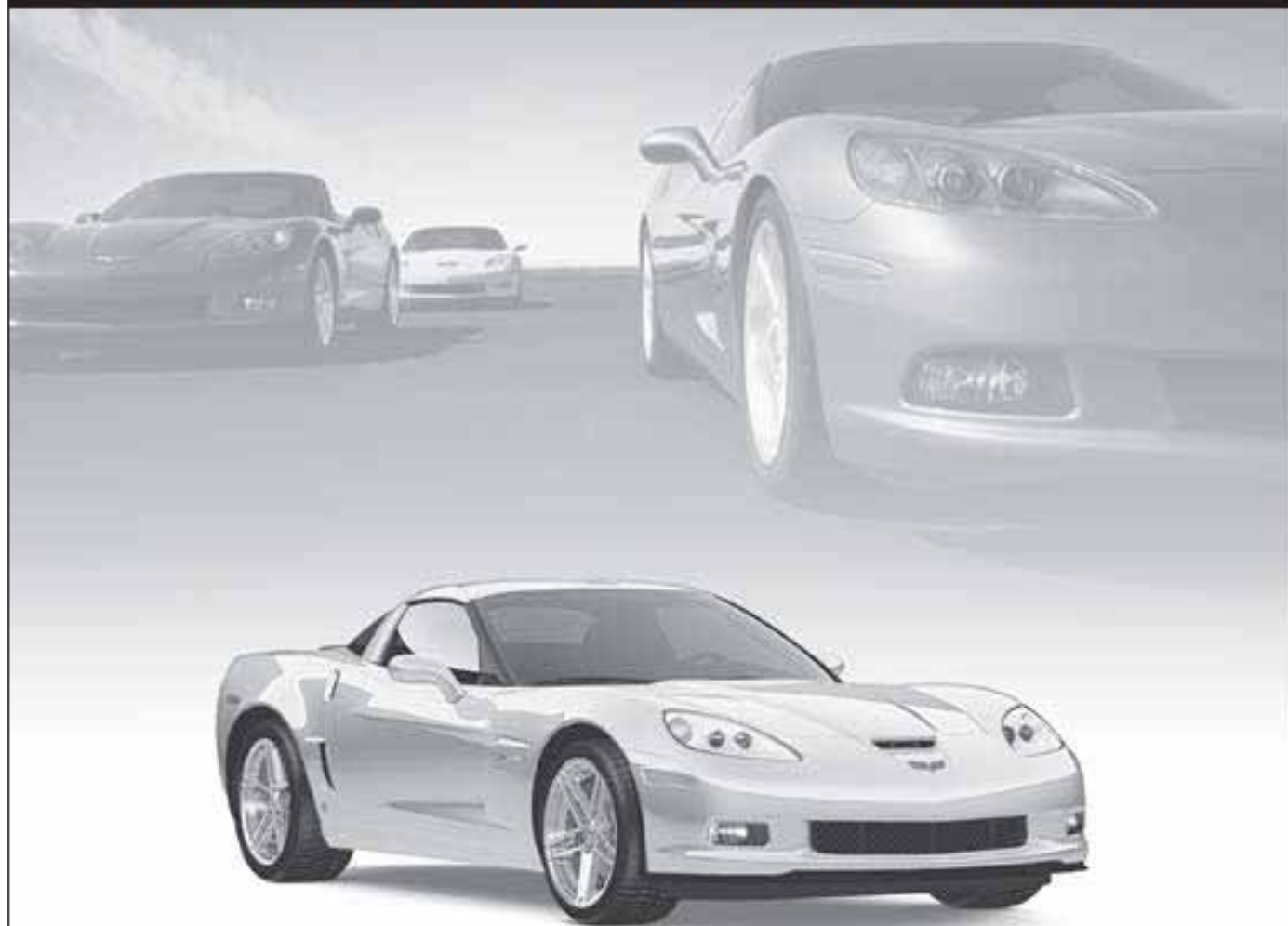
Craig said he would appoint new appointed officers in January. All appointed officers have to be approved by the board.

The meeting was adjourned at 7:45 P.M.

NCM Receives Historical Documents from NCRS

The National Corvette Museum was founded by members of the National Corvette Restorers Society with the idea of collecting and permanently storing valuable documents and artifacts related to the Chevrolet Corvette. For years we've been doing just that as our members and other Corvette enthusiasts continue to scour the planet for anything that might have historical significance regarding America's sports car. Of particular importance is the vast amount of technical data collected by the NCRS itself over the years. Dating all the way back to 1953, this treasure was intended to find its way here eventually, and now, after two decades of waiting, the first shipment has arrived.

One reason it took so long to get here was that the Museum simply was not set up to adequately store and protect these documents. With the expansion though, a state of the art archival storage room was constructed where the environment is precisely controlled. Temperature, humidity, and even the fire suppressant system was considered as this space was constructed. "The shelving system we have here was designed to accommodate this collection," said Vince Perriello, who oversees the Library and Archives. "We've waited many years for this day."

Library and Archives Manager, Betty Hardison, who has been with the Museum longer than anyone here, couldn't contain her happiness. "This is a great day," she said. "Now the work begins of getting each page in sheet protectors, organizing them into years and getting them into binders for easy access. After that we'll need to build a database that lists what is in each volume. When we're done, Corvette historians will have a window to the past with a view that goes on for miles further than ever before."

Our thanks to the members of the NCRS who faithfully collected and preserved all of this for the Corvette community and to the leadership who trusted us enough to pass it along.

The General Motors Bowling Green Assembly Plant has been home to the iconic Chevy Corvette since 1981 and currently employs approximately 590 full- and part-time employees.



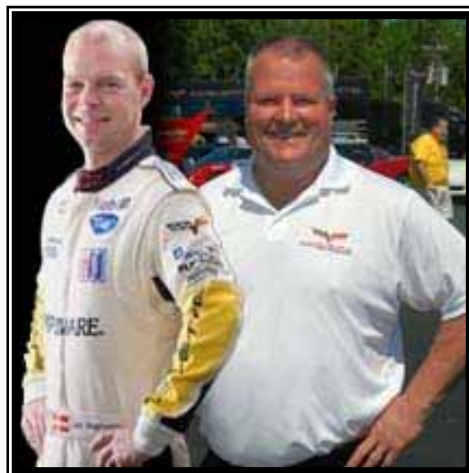

Corvette Racing Scores Two Awards at ALMS Ceremony

Corvette Racing received two nods at the American Le Mans Series awards ceremony.

Jan Magnussen was voted the Most Popular Driver in online balloting by fans. He is the only ALMS driver to have won a race in every year since the series' inception in 1999. He joined Corvette Racing for endurance events in 2004, and became a full-season driver in 2007. He was GT1 co-champion with Johnny O'Connell in 2008, and finished second in the GT championship this year with teammate Oliver Gavin. He cited the series' international appeal as a factor in his selection as the Most Popular Driver.

Dan Binks, crew chief for the No. 3 Compuware Corvette C6.R, was selected by International Motor Sport Association (IMSA) officials as the Battery Tender Mechanic of the Year in the GT class. Binks received a \$5,000 award in recognition of his wrenching and leadership skills. He then donated the award to the Austin Hatcher Foundation for Pediatric Cancer, the official charity of the ALMS, on behalf of his teammates.
