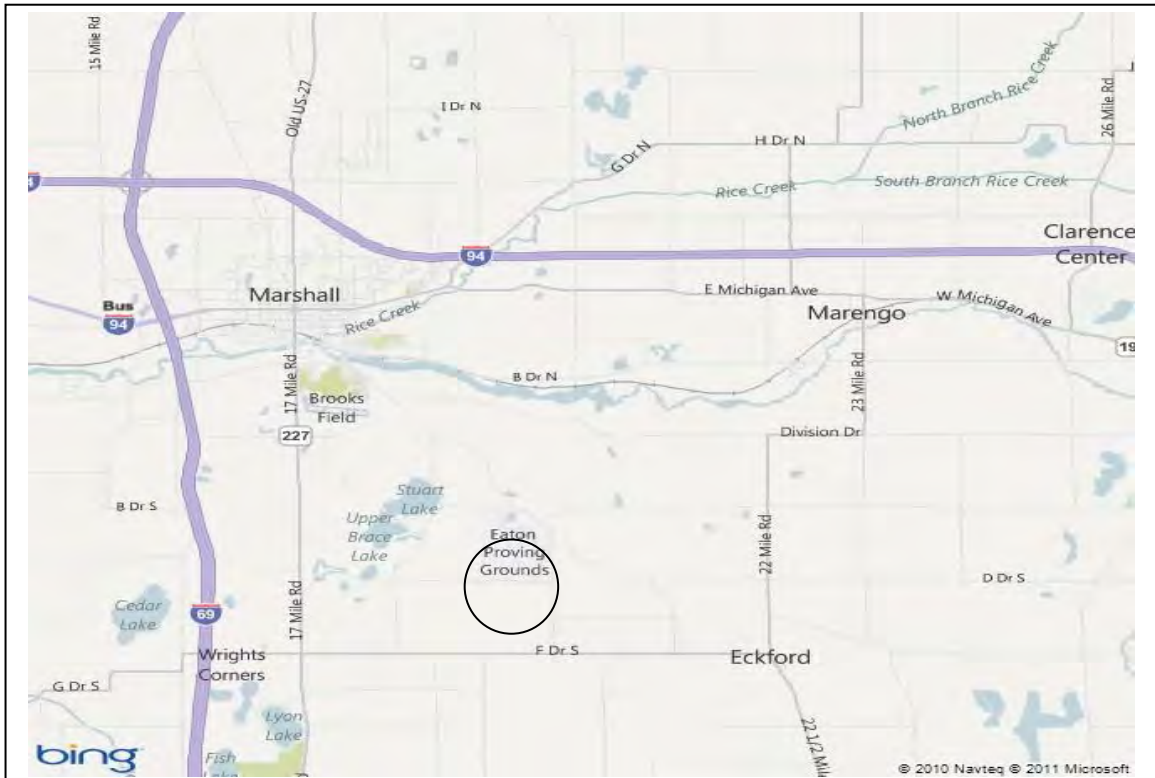

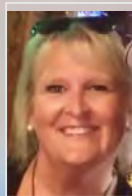

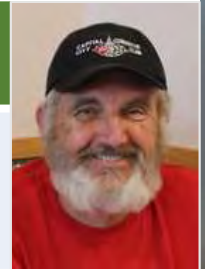

# Membership Meeting Minutes

## Capital City Corvette Club

### Membership Meeting

March 6, 2024 @ 7:00 PM: Delhi Cafe & Zoom

**7:00 Call to Order:** Kyle Felts

- Review mail received: The only mail received was a thank-you from the Lansing Food Bank for last year's donations.
- Please wear name tags: The Board discussed that it's a good idea to wear our name tags at the meetings so that newcomers can get to know us quicker.
- Thank-you to Angela for arranging the "Let's Meet for Lunch" and Gloria for organizing the "Let's Meet for Breakfast".
- National Meeting Report:
  - Governors:
    - Melissa Felts was introduced as the FCOA Director.
    - The NCM is in search of a CEO again.
    - Membership cards have been sent out, do not throw yours away, you won't get another.
    - Museum delivery cars get a one-year free membership as a member-at-large. This may be something we consider doing with Shaheen.
    - Treasurer – same budget for 2024 as we ran in 2023, we are in the negative \$67,000 annually.
  - Business Manager:
    - Working on insurance for FCOA participation.
    - There have been zero (0) insurance claims for two years.
    - As you know, the National Convention is in Joplin MO this year. The next two meetings will be held in the Wisconsin Dells (2025) and Syracuse New York (2026).
  - Charity:
    - \$36,950 given to St. Jude. At each meeting clubs bring checks to make a donation, we may consider this in the future.
    - NCCC has 20 sponsors this year.
  - Membership:
    - As of the meeting, NCCC has 17,214 members in 234 clubs. The largest club in Michigan is America's Corvette Club with 178 members. The largest Region is the West Coast, with 31 clubs. The Region with the most members is the Midwest Region.
  - NCM Deliveries: We added 103 members through the NCM delivery program since Nov 2023. The most popular colors are red, gray, white, black, and the new riptide blue.
  - Database entries: There was a reminder that Governors and Membership Directors need to send in signed copies of the NCCC application for new or returning members who have been away for five or more years.
  - Realignment and Dues Increase: Possible savings for NCCC include:
    - Raise the membership fee.
    - Realignment and combining of some of the smaller regions to cut down on the number of officers per region.
    - Move Bluebars to an online rather than hard-copy publication.
    - None of these are being implemented at this time, only discussed. If a member prefers to read Bluebars online, they can reach out to the Bluebars staff to learn how.



# Membership Meeting Minutes

- ID Cards: ID Cards were sent out but for some unknown reason were late being received by the majority of the membership. Please make sure you do not throw away the mailer thinking it is junk.
- Competition: Minutes from November 11, 2023 were approved by email and posted on the NCCC Members Only Web Section.
- Competition Database: IT Director, Walt Jenkins, did a presentation on the new updated database, and how it works. Including a new result sheet and how to upload as a .csv. Old versions will no longer work. If you have any issues, report them to Walt with screen-shots. Instructions are available online. If you have different positions (e.g. Governor and Chair) use different passwords for each level of login.
- 2023 National Competition Points are official. No protests:
  - Men - Howard Curtis and Dave Buck
  - Ladies – Lauren Killam
  - Club – Indiana Corvette Enthusiasts
- 2024 will have Speed Events and Non-Speed Events competition programs. VP and Comp Directors will assist with tech at the Convention.
- A way to implement guidelines for provisional or supplemental competition programs is under discussion.
- Rule Changes:
  - R1 – Establishing Chapter 12 – Supplemental Programs: Tabled for the May meeting for further discussions with membership.
  - R2 – FCOA Competition: Tabled for the May meeting for further discussions with membership.
  - R3 – Young Guns Speed Competition Program: Tabled for the May meeting for further discussions with membership.
  - R4 – Zora Program for top racers to compete at the Convention: Tabled for the May meeting for further discussions with membership.
  - R5 – Was designated as a suggestion for entering additional placement in drag racing results.
  - R6 – Was designated as a clarification to include additional acknowledgment of C7 and C8 classes in the sub-group FTD section. This passed unanimously 14-0.
  - R7 – Addresses the maximum number of drivers per car at an NCCC event. Will be brought back, as a clarification for a maximum of four (4) drivers.
  - R8 – Requesting to have mixed events at the same venue, up to 14 per day. Will be brought back as a clarification to the May meeting.
  - R9 – Change of distance restriction from 150 miles to 100 miles for events of the same type. Will be re-written to be at the home region RCD's discretion.
  - Clarification 2024-1: Open/Closed to classes in funkhanas (Kyle's Rule) was decided to leave it to the chairperson of the event.
  - Clarification 2024-2: Lowering the minimum age of navigators for funkhanas under 10- mph was approved by an 8-6 vote.
