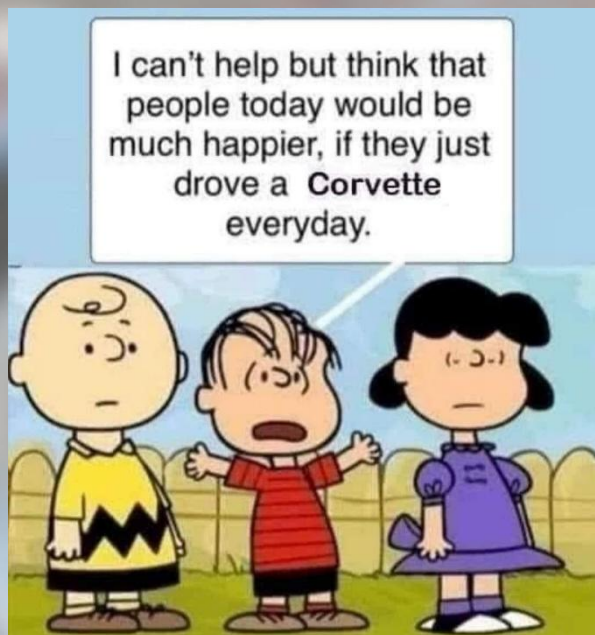

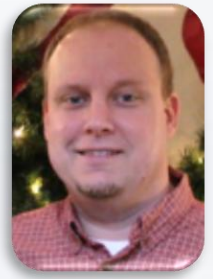

New Business:

- For the sanction fees, Kyle has the count for the Funkhanas from Blessings, but does anyone know the count for the car show. Bob said there were 47 cars.
- After the Bylaws are updated in September, CCCC will have the age for membership and NCCC youth membership aligned.
- For the Shaheen Show, we will be having more trophies and also adding special interest trophies. We might even have the "wildest" ride trophy.
- Awards for the Shaheen Show have expanded because Eric has gotten a lot more sponsors.
- CCCC members will register but our cars will not be in the judging. There are many Clubs that do this.

Other Business:

- Tom has gotten the battery for the phone for electronic payments and will be getting that set up before the next meeting.

6:50 Motion for adjournment made by Angela, seconded by Sue and approved by members in attendance.

Explanation/Clarification of NCCC Lifetime/Club Dues

I know it is not so clear as to what the renewal amounts will be going forward at this time. This is out of my control, and several members are just as confused as I am currently. So, I will try to break this down as best I can.

Here is an explanation of the NCCC Dues vs. Club Dues. They are NOT one and the same! Each club member pays membership dues at the same time for NCCC and for club dues. The Membership Director then splits out NCCC's portion of paid dues to send to NCCC. Primary NCCC \$25.00 and Spouse/Companion \$10.00. The club's dues are Primary \$30.00 and Spouse/Companion \$10.00. Therefore, a couple pays \$75.00 a year in dues to the club and the Membership Director sends \$35.00 total per couple to NCCC for their portion of the dues collected out of that \$75.00. With that being said.... Here is an explanation of what is happening with NCCC and NOT with club dues currently.....

NCCC Lifetime dues right now are \$300.00. At the September 13th NCCC Governor's meeting the governors will be voting to raise the lifetime dues to \$500.00. Our Club Governor, Simon, is confident this amount will pass in the vote to be raised to \$500.00. If interested in becoming an NCCC lifetime member, now would be the time to do so before September 13th. Then a primary member of the club would only pay \$30.00 per year for club membership dues every year thereafter and will no longer pay anything for NCCC dues.

Spouse/Companion is welcome to also sign up for NCCC lifetime membership at \$300.00. However,..... if choosing to do so... that then changes spouse/companion to primary member status of the club. Dues would also then be \$30.00 per year for club membership. A couple would then be Primary and Primary of the club, thus paying \$60.00 a year for club dues and pay nothing for NCCC as both would be NCCC Lifetime members. But as it stands, spouse/companion only pay \$20.00 currently, \$10.00 club dues/\$10.00 NCCC dues. But here is the kicker.... September 13th, governors will also be voting to raise the individual NCCC dues, possibly \$15.00 for primary and possibly \$5.00 for spouses (don't quote me, this is rumor mill on the amounts, could be more, could be less). So..... if neither member chose to go NCCC lifetime, if vote passes to raise individual NCCC dues, primary and spouse/companion would pay a total of \$95.00 per year dues instead of the normal current \$75.00 per couple if the above-mentioned amounts are what's going to be voted on for NCCC individual dues!

In the end.....lifetime primary members would end up paying \$30.00 per year for club dues and if individual NCCC dues were voted in favor of being raised, spouse/companion would end up paying \$25.00 for dues per year \$10.00 club dues/\$15.00 NCCC dues. Depending on if they voted to raise the dues by \$5.00 for spouse/companion. I believe they're only looking to raise the dues for spouse/companion by \$5.00. But again, don't quote me! I'm not entirely sure what is going to be on the ballot for the governors to vote on!

So.... If a primary member went to lifetime and spouse/companion did not.... dues would be \$50.00 unless they raise the NCCC spouse/companion dues \$5.00, then a couple would pay \$55.00 per year. Primary portion would be \$30.00 club dues and spouse/companion would be \$10.00 club/\$15.00 NCCC per year. Again... tentative amounts for NCCC membership dues until governors find out what they are voting on for NCCC! These amounts are not set in stone until the governor's vote. And remember our "club dues" portion is NOT being voted on or raised at this time.

If both primary and spouse/companion went lifetime... Club dues would then be \$60.00 total for 2 primary members, \$30.00 for each member, because you would both be primary members of the club and no longer primary, Spouse/Companion.

Hope this clears up any confusion on what is currently happening with NCCC dues membership portion. If you are still confused, please don't hesitate to call me or shoot me an email for further Explanation / clarification.
